## **NOTICE OF LOCKDOWN FOR THE STATE ATTORNEY PRETORIA DURING THE PERIOD OF 21DAYS**

In terms of the Lockdown as declared by the President of the Republic of South Africa under the provision of the Disaster Management Act 57 of 2002 and the Regulations promulgated thereto, which comes into effect at midnight on Thursday 26 March 2020 until 16 of April 2020, the office of the State Attorney Pretoria will be closed other than the matters of an urgent nature involving the State.

This Notice pertains to only **URGENT APPLICATIONS** during the lockdown period which may be brought against the state and which involves service of documents on the State Attorney Pretoria to handle such urgent matters by the Pretoria office.
